# HKFRS / IFRS UPDATE 2017/01

HKFRSs/IFRSs, HK(IFRICs)/IFRICs AND AMENDMENTS THAT ARE MANDATORY FOR THE FIRST TIME FOR 31 DECEMBER 2016 YEAR ENDS

# Background

This Update covers HKFRSs/IFRSs, HK(IFRICs)/IFRICs and amendments to HKFRSs/IFRSs that are effective for the first time in the annual financial statements of entities with 31 December 2016 year ends.

Paragraph 28 of HKAS/IAS 8 Accounting Policies, Changes in Accounting Estimates and Errors requires disclosures to be made if the initial application of HKFRSs/IFRSs, HK(IFRICs)/IFRICs and amendments has an effect on the current period or prior period (or would have an effect except that it is impracticable to determine the amount of the adjustment), or might have an effect on future periods. In most cases, retrospective application is required together with all of the related disclosures set out below. In limited cases, retrospective application to transactions that take place after a specified date) meaning that some of the disclosure requirements will not apply.

The disclosure requirements are:

- (a) the title of the HKFRS/IFRS
- (b) when applicable, that the change in accounting policy is made in accordance with its transitional provisions
- (c) the nature of the change in accounting policy
- (d) when applicable, a description of the transitional provisions
- (e) when applicable, the transitional provisions that might have an effect on future periods
- (f) for the current period and each prior period presented, to the extent practicable, the amount of the adjustment:
  - (i) for each financial statement line item affected
  - (ii) if HKAS/IAS 33 Earnings per Share applies to the entity, for basic and diluted earnings per share.
- (g) the amount of the adjustment relating to periods before those presented, to the extent practicable
- (h) if retrospective application is required but is impracticable for a particular prior period, or for periods before those presented, the circumstances that led to the existence of that condition and a description of how and from when the change in accounting policy has been applied.

HKFRS/IFRS 14 regulatory Deferral Accounts	HKFRS/IFRS 14 is an interim standard, pending the outcome of the IASB's more comprehensive Rate-regulated Activities project, which was re-opened in September 2012.	Mandatory adoption for periods beginning on or after 1 January 2016.
	In many countries, industry sectors (including utilities such as gas, electricity and water) are subject to rate regulation where governments regulate the supply and pricing. This can have a significant effect on the amount and timing of an entity's revenue. Some national GAAPs require entities, that operate in industry sectors subject to rate regulation, to recognise associated assets and liabilities.	Early adoption permitted.
	The scope of HKFRS/IFRS 14 is narrow, with this extending to cover only those entities that:	
	<ul> <li>Are first-time adopters of HKFRS/IFRS</li> </ul>

Amendments to HKAS/IAS 1 Presentation of Financial Statements	<ul> <li>The amendments made to HKAS/IAS 1 include:</li> <li><i>Materiality</i>: Aggregation or disaggregation should not obscure useful information. Materiality applies to each of the primary financial statements, the notes and each specific disclosure required by HKFRSs/IFRSs.</li> <li><i>Line items in primary financial statements</i>: Additional guidance for the line items required to be presented in primary statements, in particular that it may be appropriate for these to be disaggregated, and new requirements regarding the use of subtotals.</li> <li><i>Notes to the financial statements</i>: Determination of the order of the notes should include consideration of understandability and comparability of financial statements. It has been clarified that the order listed in HKAS/IAS 1.114(c) is illustrative only.</li> <li><i>Accounting policies</i>: Removal of the examples in HKAS/IAS 1.120 in respect of income taxes and foreign exchange gains and losses.</li> <li>In addition, the following amendments to HKAS/IAS 1 were made which arose from a submission received by the IFRS Interpretations Committee:</li> </ul>	Mandatory adoption for periods beginning on or after 1 January 2016. # Clarification of Acceptable Methods of Depreciation and Amortisation

Amendments to HKAS/IAS 16 Property, Plant and Equipment and HKAS/IAS 38 Intangible Assets	<ul> <li>HKAS/IAS 16 has been amended to prohibit the use of revenue-based methods of depreciation for items of property, plant and equipment. This is because the revenue generated by an activity that includes the use of an item of property, plant and equipment generally reflects factors other than the consumption of the economic benefits of the item, such as: <ul> <li>Other inputs and processes</li> <li>Selling activities and changes in sales</li> <li>Volumes and prices, and</li> <li>Inflation.</li> </ul> </li> <li>Guidance on depreciation has been expanded to state that expected future reductions in the selling price of items produced by an item of property, plant and equipment could indicate technical or commercial obsolescence (and therefore a reduction in the economic benefits embodied in the item), rather than a change in the depreciable amount or period of the item.</li> <li>HKAS/IAS 38 has been amended to incorporate a rebuttable presumption that amortisation based on revenue is not appropriate. The presumption can be rebutted if either: <ul> <li>The intangible asset is expressed as a measure of revenue; or</li> <li>Revenue and the consumption of the economic benefits of the intangible asset are highly correlated.</li> </ul> </li> </ul>	Mandatory adoption for periods beginning on or after 1 January 2016. Early adoption permitted.

Amendments to HKAS/IAS 16 Property, Plant and Equipment and HKAS/IAS 41 Agriculture	<ul> <li>The amendments extend the scope of HKAS/IAS 16 to include bearer plants and define a bearer plant as a living plant that:</li> <li>Is used in the production process of agricultural produce,</li> <li>Is expected to bear produce for more than one period; and</li> <li>Has a remote likelihood of being sold (except incidental scrap sales).</li> <li>The changes made result in bearer plants being accounted for in accordance with HKAS/IAS 16 using either:</li> <li>The cost model, or</li> <li>The revaluation model.</li> <li>As such, bearer plants are no longer within the scope of HKAS/IAS 41.</li> <li>However, the agricultural produce of bearer plants remains within the scope of HKAS/IAS 41.</li> <li>The amendments include the following transitional reliefs for the purposes of first time application:</li> <li>Deemed cost exemption – Entities are allowed to use the fair value of</li> </ul>	Mandatory adoption for periods beginning on or after 1 January 2016. Equity Method in Separa	ate Financial Statements	
Amendments to HKAS/IAS 27 Separate Financial Statements	The amendments include the introduction of an option for an entity to account for its investments in subsidiaries, joint ventures, and associates using the equity method in its separate financial statements. The accounting approach that is selected is required to be applied for each category of investment. Before the amendments, an entity accounted for its investments in subsidiaries, joint ventures or associates either at cost or in accordance with HKFRS/IFRS 9 <i>Financial Instruments</i> (or HKAS/IAS 39 <i>Financial Instruments: Recognition and Measurement</i> for those entities that have yet to adopted HKFRS/IFRS 9). The option to present its investments using the equity method result in the presentation of a share of profit or loss, and other comprehensive income, of subsidiaries, joint ventures and associates with a corresponding adjustment to the carrying amount of the equity accounted investment in the statement of financial position. Any dividends received are deducted from the carrying amount of the equity accounted investment, and are not recorded as income in profit or loss. A consequential amendment was also made to HKAS/IAS 28 <i>Investments</i> <i>in Associates and Joint Ventures</i> , to avoid a potential conflict with HKFRS/IFRS 10 <i>Consolidated Financial Statements</i> for partial sell downs. HKFRS/IFRS 5 Non-current Assets Held for Sale and Discontinued Operations (amended as part of Annual Improvements to HKFRSs/IFRSs (2012 – 2014 Cycle) The amendment clarifies that the reclassification of an asset or disposal group from being held for sale to being held for distribution to owners, or vice versa is considered to be a continuation of the original plan of disposal. Upon reclassification, the classification, presentation and measurement requirements of HKFRS/IFRS 5 are applied. If an asset ceases to be classified as held for distribution to owners, the requirements of HKFRS/IFRS 5 for assets that cease to be classified as held for sale apply.

HKFRS/IFRS 7 Financial Instruments: Disclosures (amended as part of Annual Improvements to HKFRSs/IFRSs (2012 – 2014 Cycle) The amendments to HKFRS/IFRS 7 dealt with two aspects: servicing of contracts and the applicability in interim financial statements of the offsetting amendments made to HKFRS/IFRS 7 in December 2011.

(i) Servicing contracts

The IASB clarified the circumstances in which an entity has continuing involvement from the servicing of a transferred asset. Continuing involvement exists if the servicer has a future interest in the performance of the transferred financial asset. Examples of situations where continuing involvement exist are where a transferor's servicing fee is:

- A variable fee which is dependent on the amount of the transferred asset that is ultimately recovered; or
- A fixed fee that may not be paid in full because of non-performance of the transferred financial asset.

The amendment is required to be applied retrospectively in accordance with HKAS/IAS 8 *Accounting Policies, Changes in Accounting Estimates and Errors.* However, the amendment does not need to be applied for any period beginning before the annual period in which the entity first applies the amendments. A consequential amendment has been made to HKFRS 1 *First-time Adoption of Hong Kong Financial Reporting Standards*/IFRS 1 *First-time Adoption of International Financial Reporting Standards*, in order that the same transitional provision applies to first time adopters.

(ii) Applicability of offsetting in condensed interim financial statements

A further amendment to HKFRS/IFRS 7 has clarified that the application of the amendment *Offsetting Financial Assets and Financial Liabilities* (Amendments to HKFRS/IFRS 7) issued in December 2011 is not explicitly required for all interim periods. However, it is noted that in some cases these disclosures may need to be included in condensed interim financial statements in order to comply with HKAS/IAS 34.

Amendments to HKAS/IAS 34 Interim Financial Reporting	<ul> <li>HKAS/IAS 34 requires certain disclosures to be presented in the notes to the interim financial report, unless they are presented elsewhere in the interim financial report (such as a front end management report).</li> <li>If the disclosures are presented 'elsewhere' in the interim financial report, such as in the management commentary or the risk report of an entity, a cross reference must be made from the notes to the interim financial statements to where the disclosures have been made.
